#### **History Note**

The government of the Territory of Utah created the office of Salt Lake County Recorder in 1852. The recorder has custody of and is to keep all books, records, maps, and papers required by law (Utah Code Unannotated, 1999, Title 17, Chapter 21, Section 1). The operations of the county recorder are all specified and required by state law and have changed little over time. The recorder is required to record all documents submitted by the public which are qualified to be recorded; to maintain an up-to-date and accurate set of maps (or "plats") which show the current ownership of every tract of land in the entire county; to maintain indexes to all recorded documents; and to perform all functions of a clerical and technical nature to accomplish that objective. Mining records are kept by the county recorder for the purpose of monitoring and registering mining claims and operations. The record of mining locations typically shows the claim name and location; legal description of claim; and the mining district. Proof of labor affidavits describe and allocate a monetary value to the work reportedly done at each mine claim annually. Placer location notices show name and description of claim. Mining deeds record information affecting the title of mining property; and abstract of mines records instruments affecting title patented mining claims which include type of instrument filed with the county recorder.<sup>1</sup>

#### **Scope and Content Note**

Notice of Location for Mining Claims:

This series contains the original Notice of Location certificates for mining claims in Salt Lake County. These notices contain the name of the mining claim, the person(s) associated with that claim and a geographical description of the claim's location. This series dates from August 5, 1897 to April 24, 1905.

Index to Mining Location Notices, E, 1897:

This index is an alphabetical listing which includes the following information: date of filing, page number, the name of the mine and the name of the person filing notice. This index has entries from May-December of 1897. The 1897 Notices of Location for Mining Claims held by the archives are indexed in this volume, however it should be noted that many of the claims listed in the index have no corresponding Notice of Location in the collection.

Index to Mining Location Record, F, 1897:

This index is a listing of the following information, date of filing, page number, name of person the filing was from and to, and the type of filing (for example, a location notice or location certificate). This index has entries from May-December of 1897. Note: Though this seems to be very similar to Index to Mining Location Notices, E, the fact that it covers the same time period and has no corresponding records in the Notice of Location for Mining claims may indicate that this index served a different purpose.

Index to Notices of Location of Mining Claims, 1897-1950:

Two indexes, the first arranged alphabetically by the location name and the second by the last name(s) of the locator(s). Fields include: claim entry number, location date, filing date, book, page number, location name, mining district, and locator name.
