


1. Go to the Employee Connect, click on “Internal Websites”. Then scroll down to just below “Contracts & Procurement” **OR** to “Purchasing”, click on “Search current contracts”, which will bring-up the SharePoint Document Search Tool.



2. At the SharePoint Document Search Tool, select your search option (e.g. Contracts, Purchase Orders, or Insurance):




3. You can search by Vendor Name, Description, Contract Number or Start and End Dates. This allows more flexibility in searching. If you know the contract you’re looking for is with the State of Utah and was effective sometime after 12/31/2018 you can add multiple search criteria, so you are only pulling up contracts with the State of Utah with a start date Greater Than (or after) 12/31/2018.

- When the Contract information displays you can click on **any** of the column headers to sort that column in ascending or descending order for that specific column:
