CALL TO ORDER:

The meeting was called to order at approximately 7:34 AM by Michele Corigliano, Chair of the Salt Lake County Board of Health.

CITIZEN PUBLIC COMMENT:

Comments are limited to 3 minutes unless otherwise approved by the Salt Lake County Board of Health. Jeffery Haasch provided comment on his overall dissatisfaction with the Health Department and the Board of Health.

MINUTES:

Michele Corigliano, Chair, asked if there was a motion to approve the minutes from the January 5, 2023, Board of Health meeting. *The motion was made by Dan Eckersley, seconded by Stacey Bank, to approve the minutes from the January 5, 2023, Board of Health meeting.* The motion passed unanimously, showing that all Board members present voted “Aye.” Michele Corigliano, Chair, asked if there was a motion to approve the amended minutes from the October 6, 2022, Board of Health meeting. *The motion was made by Mayor Mike Weichers, seconded by Stacey Bank, to approve the minutes from the October 6, 2022, Board of Health meeting.* The motion passed unanimously, showing that all Board members present voted “Aye.”

CHAIR'S REPORT:

Michele Corigliano, 2023 Chair, let the Board know that the UALBOH Symposium will be held on April 26-27. Board members are encouraged to attend. Registration information will be sent by email.

DIRECTOR'S REPORT:

Ron Lund, Environmental Health Division Director, gave the Director's report. He informed the Board that hospital visits for RSV, Covid-19 and Flu are low. Emergency department visits for covid related symptoms make up 1.7% of all emergency department visits.

Ron reminded the group being vaccinated is the best way to remain protected against Covid-19. Salt Lake County has 12% of its population who are up to date with their Covid-19 vaccine.

Ron let the Board know about a Health Department initiative that focuses on health equity. This initiative has a focus on health equity and cultural understanding. This effort includes online and in person training.

The Health Department's Workforce Development Committee is currently working on an assessment to understanding where staff is with their level of understanding of health competencies. The results will shape their workforce development plan and training implementation.

Ron informed the Board of a Flu Pilot Program for testing and treatment of Flu. Clients will be tested for Flu and Covid at SLCoHD's testing locations and those who test positive for Flu will be provided a prescription for Tamiflu.

Ron informed the Board that Samsung has been a partner with Salt Lake County Health Department in their e-waste program. Samsung has paid for electronic waste to be recycled that is dropped off from residents for the past decade. They informed the Health Department they may not continue this service.

Ron informed the Board that the Household Hazardous Waste building being built in Sandy should be breaking ground in coming weeks.

LEGISLATIVE UPDATE:
