00:54	Crisis Response Recommendations Presentation – Allison Heffernan Allison Heffernan, Office of Homelessness & Criminal Justice Reform (OHCJR), presented on the Crisis Response Report and Recommendations. This included a data recap, research, and the overview of gaps in the current system. A full review of all 6 recommendations were conducted: 1. Establish SLCo Crisis Response Coordinating Task Force; 2.Centeralize Post Crisis Care Program; 3.Cross-System Data Integration; 4.MCOT Transportation; 5. Enhance Co-Response Coordination; and 6. Enhanced Trainings for First Responders.

25:08 OHCJR Legislative Report – Sebastian Green

Sebastian Green, Office of Homelessness and Criminal Justice Reform, discussed the 2025 Legislative Report that was shared with the group. He provided a brief overview of the report highlights, bills that impacted the Criminal Justice and Homelessness systems, and budgets.

30:00 Legislative Update - Rich Mauro and Brett Robinson

Rich Mauro, Executive Director of LDA, and Brett Robinson, Chief Policy Advisor SLCo DA, provided an overview and highlights that may impact the group and related systems from the 2025 legislative session. This included the following topics: Effective date, political climate, number of bills and breakdown, high impact bills, narrow misses that may recirculate, enhanced crime bills, and other criminal justice related bill.

In depth review of each bill was conducted, presentation will be made available for review.

Data Highlights:

959 total bills this session, 583 passed, 27% Criminal Justice Related (increase seen last two years) 54 bills passed that impacted crime penalties (4 decreased, 50 increased)

1:19:20 Review of 312 Implications on the Salt Lake County Jail – Chief Matt Dumont

Chief Dumont, Salt Lake County Jail provided the impacts of HB 312 and changes that will be seen at the Salt Lake County Jail, and other systems reactions.

- 1. Impacts to Over Crowd Release- degree of felony is considered
 - a. Over Crowd Criteria for felony possession charges
 - b. Repeat offenders (w/in 12 months) and failure to appear anticipated overlap in these populations
- 2. Contracting If jail is releasing individuals in violation of criteria, required to seek contractual relationships with other county jails and prisons in Utah.
 - a. Previous experience with this highlighted challenges in transportation
 - Looking at reviewing and revamping administration plans for alternatives such as ankle monitor program.
 - Additionally to address bed capacity at SLCo Metro Jail, remodeling to fully open Oxbow Jail opening.
 - d. Working with Justice Courts to clear charges
- 3. Minimum amount of time individual must stay in jail if on a 72 hour hold
 - a. Increases time to allow AP&P can respond
