00:05 **Welcome from Chair Sheriff Rivera**

Chief Dumont made a motion to approve the minutes from the August 14<sup>th</sup> meeting, Anndrea Wild seconded the motion, all were in favor.

It was proposed to move the December 2024 CJAC Meeting to November in order to accommodate Strategic plan deadlines as well as the increased travel during the holidays. It was approved, the next CJAC meeting will be on 11/13/2024.

02:13 **Downtown Safety Initiative (DSI) Update**

Chief Mike Brown with SLC PD began the presentation by introducing the DSI project, project area, goals, and partners involved. He also discussed the successes of the project to date, as well as some of the barriers identified since starting. Review of high utilizers (those who are arrested multiple times within a short time frame) and the frequency they are being encountered occurred.

20:11 Kele Griffone discussed those individuals in the DSI boundaries that were booked into jail and had contact with pretrial services. Data was reviewed about this population including, demographic data, arrest record history, encounters this population has had, lead booking charge, and those identified as high risk. The question was raised how do we get this population access to services that they need including services after 5 pm, finding services when beds are full etc.

28:49 Josh Draper reviewed what AP&P has done to support the project as well as the rehabilitation of the clients. He reviewed how they have been able to take clients who are in recovery assist with the clean up efforts of the project. Josh reviewed his statistics from clients who have interacted with AP&P and are classified as high utilizers. He emphasized the need for resources for high utilizers.
